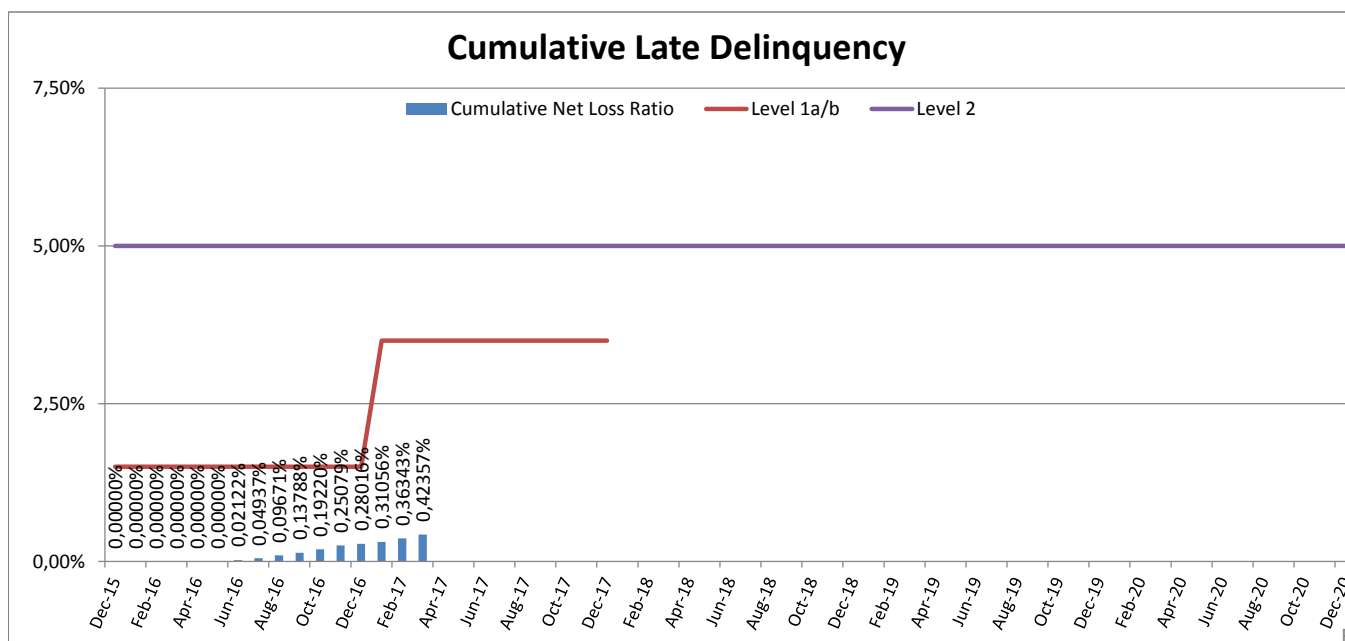

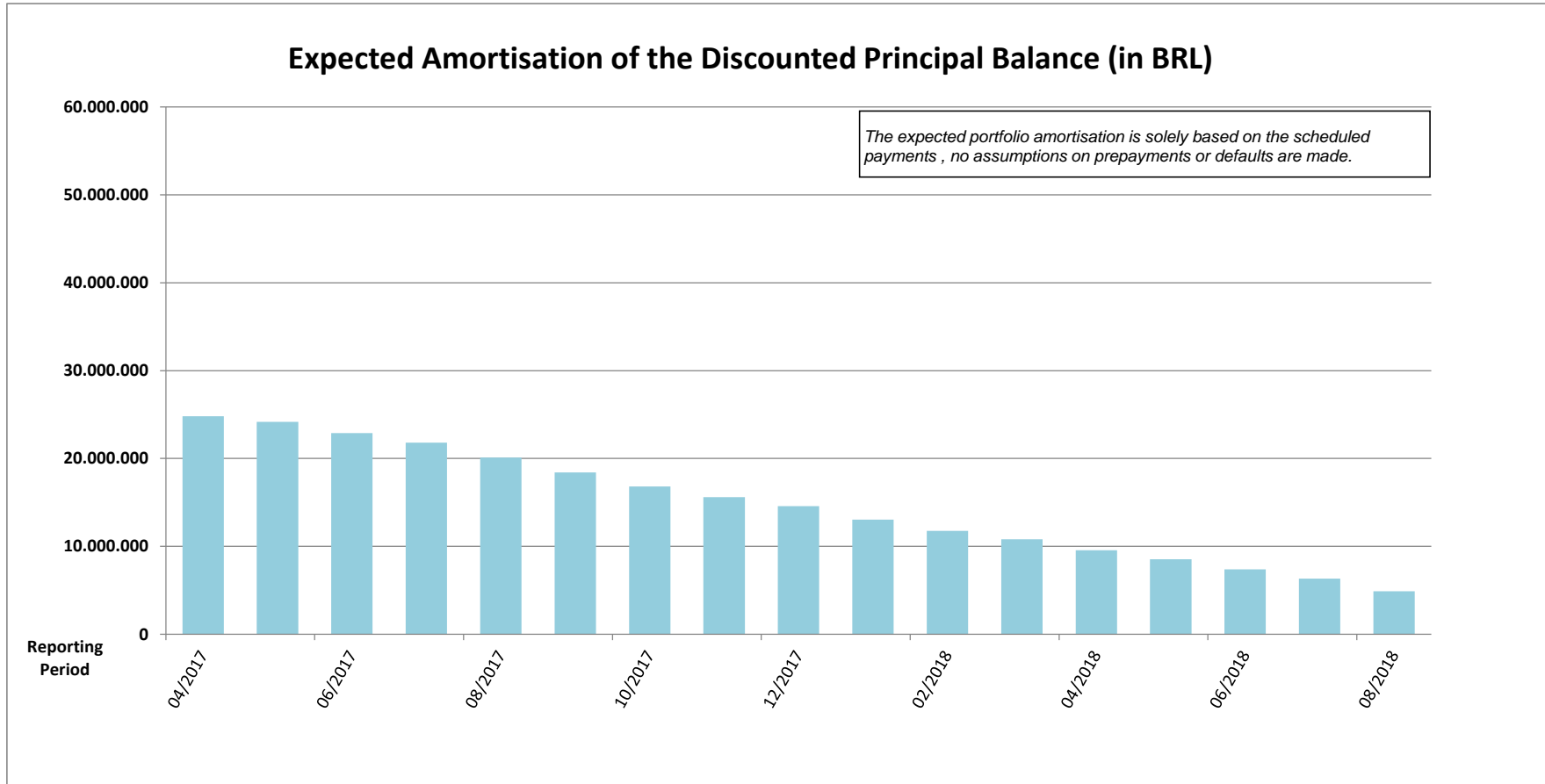
Amortisation Profile II

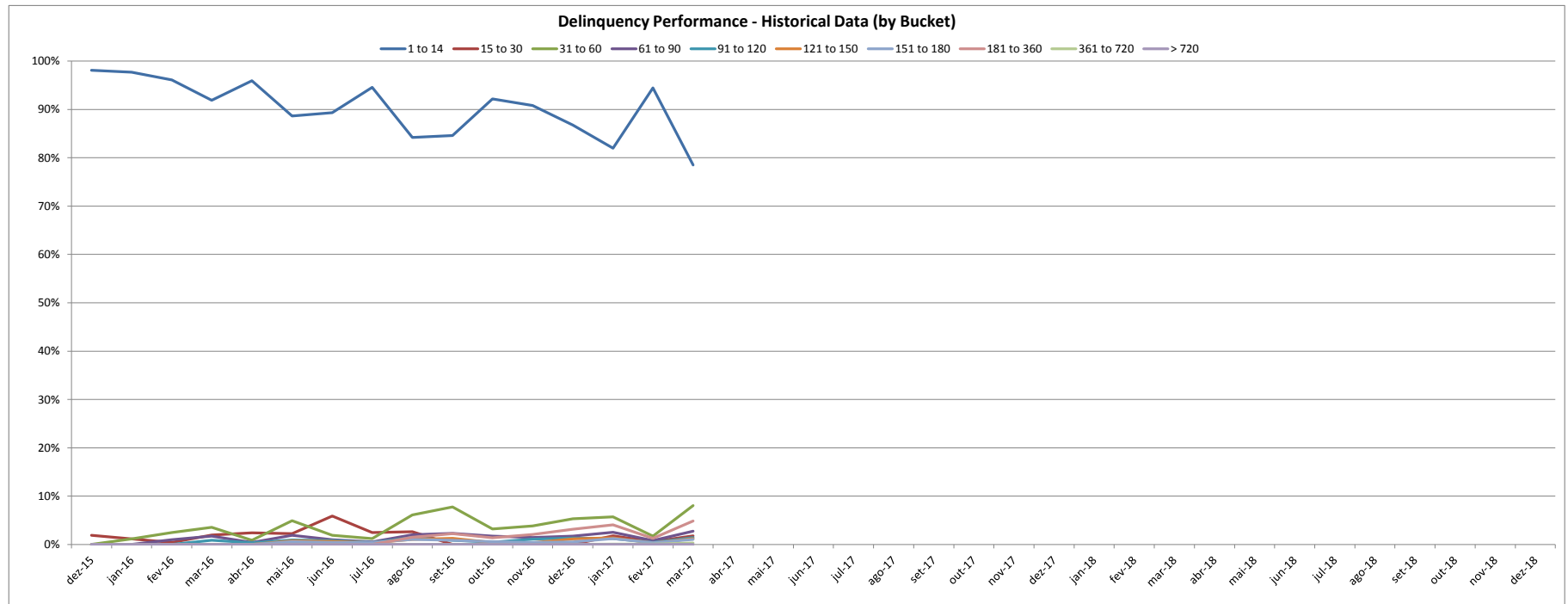
